Presentation of the Web Bankruptcy Project

ZAGREB - The project "High Commercial Court of the Republic of Croatia – Web Bankruptcy" was presented in the Government yesterday. It should ensure complete transparency of bankruptcy procedures and allow potential buyers in Croatia and abroad simple access to information on bankruptcy assets offered for sale.

The project concerns a specialized bilingual (Croatian and English) web page which follows bankruptcy procedures led before all commercial courts in the country.

The web page, *inter alia*, offers an overview of bankruptcy regulations, information on bankruptcy judges and trustees as well as photographs, land registry excerpts and value estimates of the assets sold in bankruptcy proceedings.

The Minister of Justice Ana Lovrin stated that this is another step in judicial reform and prevention of corruption through establishing a more efficient and transparent public administration.

She emphasized that the project was realized in cooperation between the Ministry and the non-governmental association Judge's Web and that it did not burden the state budget since all the costs have been fully covered by foreign donations.

The President of the High Commercial Court of the Republic of Croatia Srđan Šimac pointed out that this is "a world unique project fully envisioned and implemented by domestic intelligence". Šimac expects that the presented web page will facilitate the sale of bankruptcy assets for which, in his opinion, there will be more potential buyers than now.

The idea for the project came from the judge of the High Commercial Court Mario Vukelić and the project was technically implemented by Judge's Web.

Predstavljen projekt 'web stečajevi'

ZAGREB - U Vladi je jučer predstavljen projekt "Visoki trgovački sud RH - web stečajevi", koji bi trebao osigurati punu transparentnost stečajnih postupaka, a potencijalnim kupcima u Hrvatskoj i inozemstvu omogućiti jednostavan pristup podacima o stečajnoj imovini koja se prodaje.

Riječ je o specijaliziranoj dvojezičnoj (hrvatski i engleski) internetskoj stranici, koja prati stečajne postupke što se vode pred svim trgovačkim sudovima u zemlji.

Stranica, među ostalim, nudi pregled stečajnih propisa, podatke o stečajnim sucima i upraviteljima, te fotografije, zemljišne izvatke i procjenu imovine koja se prodaje u stečajnim postupcima.

Ministrica pravosuda Ana Lovrin ocijenila je da je riječ o još jednom koraku u reformi pravosuda i prevenciji korupcije kroz stvaranje učinkovitije i transparentnije javne uprave.

Naglasila je da je projekt nastao u suradnji Ministarstva i nevladine udruge Sudačka mreža, te da nije opteretio državni proračun budući da su troškovi u cijelosti pokriveni inozemnim donacijama.

Predsjednik Visokoga trgovačkog suda RH Srdan Šimac naglasio je da je riječ o "u svijetu jedinstvenom projektu, koji je u potpunosti osmislila i provela domaća pamet". Šimac očekuje da će predstavljena stranica olakšati prodaju stečajne imovine, za koju će se, drži, ubuduće javljati više potencijalnih kupaca nego do sada.

Idejni tvorac projekta je sudac Visokog trgovačkog suda Mario Vukelić, a tehnički ga je provela Sudačka mreža. (H)
